## Nathan Hale Junior Huskies Youth Football Parents Code of Conduct



Parents and spectators are expected to conduct themselves in a manner that demonstrates respect to other parents, players, coaches, officials, and fans. I recognize and accept my responsibility as a parent or guardian of a Jr Huskies player and pledge to follow this Parent's code of conduct.

## As a parent or guardian, I will follow the guidelines set forth by the Nathan Hale Jr Huskies:

- I will NOT be a sideline coach or referee. I will limit my comments to positive reinforcement and encourage my child and the team.
- I understand that as a parent or guardian, it is my responsibility to communicate with the coach if my child will not be attending practice.
- I understand that Teamsnap is our main portal for communication, and I will pay attention to messages sent
- I will be respectful of the coaches' time and arrive promptly to pick up my child from practice and/or games.
- I understand that if my child does not show up for practice, they may not play in the game. Practice is vital for playing any sport.
- I understand that if my child loses or intentionally damages their issued equipment, I will be held responsible for paying for the repair and/or replacement of that equipment.
- I understand that my volunteer fee will NOT be returned to me (even if I fulfill my required volunteer time) if my
  child does not turn in the equipment at the end of the season.
- I will not force my child to participate in football
- If my child develops a behavior-related problem that repeatedly disrupts practices and/or games, I will work with my child and the coach to resolve the problem.
- I will refrain from the use of foul or offensive language.
- I will respect the 24-hour rule when communicating with a coach after a game. Emotions run high especially after games. Cool heads will prevail.
- I will not be a distraction to my child during practice or games. I will refrain from engaging in conversation with them or calling their attention away from practice or games. Players must remain focused.
- I will respect the officials and their authority during the games, and I will not argue with the officials no matter the circumstances. The coaches will handle all matters pertaining to the officiating.
- I will not engage in physical or verbal confrontations with players, coaches, officials, or fans before, during or after practices or game competitions.
- I understand that my poor behavior during practices or games may result in my expulsion from the football complex where I must wait for my child in the parking lot to finish practicing or playing. If this occurs regularly, I understand that I may be banned from attending games and/or practice for the remainder of the season.
- I understand that if my child engages in any unsportsmanlike conduct, physical attack, including but not limited to, the laying of a hand upon, pushing, shoving, striking, or kicking of any teammate, coach, participant, spectator, or team representative on or off the field that they will be subject to disciplinary action as outlined below.
- ✓ Verbal warning by the coach, official, director or board member of the Nathan Hale Jr Huskies football program.
- ✓ Game(s) suspension with written documentation of incident kept on file with Jr Huskies football board
- Expulsion from the organization as determined by the Jr Huskies football board. All monies will NOT be refunded in whole or part.
